



2020 AWWA Bonanza Program Competition Enrollment Form
Sponsored by Eleanor's Arabian Farm

Competition Enrollments for the AWWA Bonanza Program sponsored by Eleanor's Arabian Farm are accepted until close of entries for U.S. Nationals. However, the enrollment fee increases the closer the date to start of U.S. Nationals. To compete for Bonanza prize monies a horse must have an Enrollment Form on file with the AWWA and be sired by an AWWA nominated parent. A list of permanently nominated AWWA stallions can be found at www.arabianworkingwestern.com. Horses wishing to compete for AWWA Bonanza prize money, but are not sired by an AWWA nominated parent, may still participate in the Bonanza Program by paying a one-year parentage nomination fee of \$250. A copy of horse's registration papers MUST accompany the Competition Enrollment form.

To compete in the 2020 AWWA Bonanza Program sponsored by Eleanor's Arabian Farm, a horse must meet the conditions above and be properly entered in the corresponding class(es) held at the 2020 AHA Arabian & Half-Arabian U.S. National Championships in Tulsa, OK. Exhibitors need not designate specific classes to AWWA. One AWWA Competition Enrollment Form per horse qualifies that horse for all AWWA Bonanza designated classes providing the horse is properly entered in the class through AHA Show Office. Do not send this Competition Enrollment form to AHA.

The appropriate Competition Enrollment Fee plus \$15 Administration Fee must be paid in order to compete for Bonanza prize monies. This Competition Enrollment Form along with a Copy of Horse's Registration Papers, and correct Payment Fee must be sent to the address on this form. This entry is nonrefundable. Full payment must accompany this form to be accepted. Any returned checks will be subject to a late fee, and party will be responsible for any and all costs and fees incurred with collection, including but not limited to attorney's fees.

OWNER INFORMATION- PLEASE READ CAREFULLY

In order to receive any prize money pay outs, winning horse owners must send the AWWA a completed W9 form within sixty days of the completion of US Nationals. If the W9 form is not received within that time, no pay out will be issued. Prize money checks must be cashed within 90 days of the date issued. Checks will be considered void after that time. It is the responsibility of the Owner to provide the required information to AWWA.
