

2023 Arabian Working Western Alliance Breeding Contract for E Zee Slider+/-

This contract is for the 2023 breeding season according to the Arabian Working Western Alliance Breeding Auction Rules. The normal breeding fee to E Zee Slider+/- is \$1500 USD.

All shipping and collection fees are in addition to the breeding fee and are to be paid by the client directly to the Veterinary Clinic and stallion handler before the semen is shipped. Shipping and handling must be paid in advance or semen will not be shipped. Shipping and handling will be at the handler and facilities costs. Fees are in US Dollars.

Semen is a collection of cooled semen that can be picked up at the collection facility or shipped by major carrier. Each time the stallion is collected for nominated mare, there will be a handling fee to stallion handler, and collection/ shipping fee to Veterinary Clinic. Shipments to Canada will be handled by the collection facility and entail a health certificate in addition to shipping fees. The mare owner will be responsible for all expenses incurred. Every effort will be made to provide a viable semen shipment, but due to shipping complications, there are no guarantees. If semen was shipped viable and arrives damaged or late, the mare owner is still responsible for all costs and risks. There are no guarantees.

Mare owner must notify stallion handler 48 hours prior to shipment that there may collection and shipment required. Verification 24 hours ahead of collection is required. Collection and shipping days will be established at the beginning of the breeding season, and the mare owner will be notified. Every effort will be made to make the stallion available for collection on established collection days. There may be days the stallion is being shown or the stallion handler may not be available. Advance contact with the stallion owner and handler is recommended to avoid problems.

OR:

If the client prefers frozen semen, ONE shipment of frozen straws will be made. There will be enough straws provided to breed the mare twice. There will not be any additional shipment of frozen included in this breeding. There are no guarantees with frozen semen. There have been pregnancies produced by frozen semen. The shipping fee will be in addition to the breeding fee and will include transport of shipping container to and from the mare owner. If shipping container is not returned, the mare owner will be responsible for replacement value of the vapor shipper.

If multiple pregnancies or embryos are produced by either cooled or frozen semen, only the initial purchased breeding is covered by the Arabian Working Western Alliance payment. Any additional pregnancies or embryos produced by these shipments will cost an additional \$1500.00 USD paid directly to the stallion owner, Connie Schmidt Walling. If additional embryos or pregnancies are attempted or intended to be attempted, the mare owner must notify Connie Schmidt Walling during the 2023 breeding season, or all additional pregnancies will be null and void.

There is no live cover.

This breeding contract is for listed mare only. Any mare may inseminated with the purchased semen, but the listed mare and a copy of her papers must be provided to the stallion owner before shipment. This breeding is not transferable to another person or mare and if the mare owner wishes to substitute a mare, the stallion owner must authorize so in advance of doing so or breeding will be null and void.

There is no guarantee of any kind with frozen semen. There is a Live Foal Guarantee with shipped cooled semen. The guarantee is that the foal is born alive and survives for 24 hours. If the foal does not do so, there must be immediate notification by a licensed veterinarian within 24 hours of a birth/death in order to qualify for a rebreed. A rebreed fee of \$750 shall be paid to Connie Schmidt Walling and all prior collection/shipping/frozen shipment shall apply. Breeding must be used during the 2024 season and no further guarantees apply.

In the event of the stallion's death, frozen semen will be substituted at the client's expense. If the stallion is sold, all signed breeding contracts will be honored.
