The foal will be born in 2024 out of the mare named below and sired by the stallion listed on this form. The form must be submitted with payment prior to December 31, 2023.

This nomination is for the 2023 breeding season. The foal to be born in 2024 will be eligible to compete in the AWWA Ranch Horse Challenge Incentive Fund program as a four-year old. A mare nomination fee of \$150 (plus an office fee of \$25) must accompany this form. 100% of the mare nomination fee will be used as prize money for the Incentive Fund. An entry form with appropriate entry fees will be due at time of entries for resulting foals to compete at U.S. Nationals. It is the responsibility of the mare owner/lessee to notify the AWWA of any changes in address or change in ownership of the nominated mare or resulting foal. The nomination form and associated nomination fee are non-transferable to another horse. All nomination fees are non-refundable.
