Upon completion of the form and submission of payment the horse named above will be issued an Incentive Fund Certificate that allows them to compete for Incentive Fund monies & prizes during their 4-year old year in the Ranch Horse Challenge. *100% of nomination fees will be used as prize money for the Incentive Fund. An entry form with appropriate entry fees will be due at time of entries for resulting foals to compete in the AWWA Ranch Horse Challenge at U.S. Nationals. It is the responsibility of the horse owner/lessee to notify the AWWA of any changes in address or change in ownership of the nominated horse. All associated nomination fees are non-transferable to another horse. **All nomination fees are non-refundable.***
